In our desire to give further time for these individuals to listen to the church, and perhaps be drawn to repentance and restoration, this motion is being presented today but will not be finalized until next month.

*Further Detail:*

This matter has been addressed biblically according to Matthew 18:15-17. The couple was first addressed in private, then with witnesses. For months, they have been addressed both individually and together. Despite acknowledging that their actions are indeed wrong, neither individual has yet to exhibit repentance by changing their course of action. Therefore, the matter is now being brought before the church, according to Jesus' teaching. Our desire is for the church to lovingly reach out to this couple over the next month and encourage them toward repentance. If repentance (not merely sorrow) is displayed by one or both of them, then membership will be maintained for repentant person/s. If repentance is not displayed, then membership will be removed, and we will treat the unrepentant person/s as unbelievers, as Jesus taught us to do. If we indeed reach the point of removing membership for one or both of them, then the elders will provide further detail to the church about how we should interact with them moving forward.
