Motion 2206.11. Benevolence/Counseling Expense Approvals.

The Finance Committee moved that the church approve the following changes to the 2022 Budget breakpoints and approval authorities for the accounts/expenses shown:

1. Benevolence.

a. Breakpoint level:

i. Level I: increase from \$500 to \$1,000.
ii. Level II: increase from \$1,000 to \$5,000.
iii. Level III: increase from \$2,000 to \$7,500.
iv. Level IV: increase from \$2,000 to \$7,500.

iii. Level III: increase from \$2,000 to \$15,000.
iv. Level IV: increase from \$2,000 to \$15,000.

b. Approval authorities:

Body of Elders to the overseer list.

ii. Level II: the Body of Elders (for both other overseers and paid

staff).

iii. Level III: no change.iv. Level IV: no change.

Aaron Perry made an amendment to divide the motion into two separate motions: Benevolence and Counseling; Paul Whitacre seconded. Motion to amend failed.

Tim West made an amendment to make the breakpoint levels in the Benevolence category match the breakpoint levels in the Counseling category; Rick Lemons seconded. Motion to amend failed.

Phil Wing made an amendment to take the Counseling breakpoint levels to the following amounts:

I. Increase from \$ 500 to \$2,000.
