The above escrow funds will be put into separate escrow accounts, overseen by the Finance Committee. The Finance Committee can delegate oversight of specific escrow accounts to individuals or committees subsequent to this motion passing. Motion passed.

## Motion 2303.07. Facility Expansion Expense Delegation Extension until WSC Full Occupancy Plus.

The Director of Finance and Facilities, in consultation with the lead pastor, moved that the church extend Motion 2107.06, Facility Expansion Expense Delegation, effective January 1, 2023, until the end of the third month after WSC full occupancy authorization is granted by Greene County Department of Building Regulation. This request is consistent with a provision in that motion to allow extensions by a vote in a Members' Meeting. Motion passed.

# Motion 2301.08. Affirm Jim Patterson as UBC Trustee through October 31, 2025.

The UBC Body of Elders moved that Jim Patterson be affirmed by the church as a trustee (an administrative officer of the church) starting now and continuing until October 31, 2025, the end of a three-year term. Motion passed.
