Motion 2203.12. Budget Authority Transfer to Deacon Body Operations.

The deacon chairman and staff moved that the church authorize the transfer of \$1,600 from Contingencies HERE to Deacon Body Operation budget account.

Motion 2203.13. Accept 2022 Audit of 2021 Financial Records.

[Jeff VanScoy had served as audit lead; hence, Tim West stepped in to moderate the motion.] The Finance Committee moved that the church accept the attached audit report concerning the 2022 Annual Audit of Financial Records for the 2021 fiscal year done on January 22, 2022. This audit included pay records in addition to income and expense records. In addition, the Finance Committee would like the church to thank the team (Jeff VanScoy, lead; and Bill Jones, Mike Avery, Aaron Coontz, Phil Mangan, Rob Patino, Janice Patino, Bob Pickle, and Johnny Richardson) for their diligence, thoroughness, and giving up their Saturday midday to do the audit. Motion 2203.14. Increase Face Value of Construction Loan Solicitation.

The Facilities Expansion chairman (Tom Hamilton), vice-chairman (Harry Steck), and lead pastor (Jason Wing) moved that the church approve the Facility Expansion Committee to pursue and acquire a construction loan (or loans) for up to an increased face value (line of credit) of \$4.75M.
