The Personnel Committee moved that the church designate Director of Groups Ministry Bryson Jackson's 2024 housing allowance to be \$22,500. This motion has Federal income tax implications that can benefit the employee. Motion passed.

## Motion 2311.11. 2023 Budget Authority Transfer #7.

The Finance Committee moved that the church authorize the transfer of the 2023 Budget Authority between budget accounts as shown below (rationale explained in agenda):

# Motion 2311.12. The 2024 Financial Budget.

The Finance Committee moved that the church approve the attached Calendar (CY) 2024 budget.

Parliamentary Procedure. This motion is being introduced to the membership in this Members' Meeting for their prayer, reflection, and consideration until the next Members' Meeting. The plan is to vote at the next Members' Meeting on the motion and hence adopt the 2024 budget. The DRAFT budget is subject to revision based on questions at the Members' Meeting and follow-up questions and review.

The attached budget track sheet shows the 2023 Make Him Known budget as a starting point (in format and values). The budget account titles were updated to reflect 2024 names, and account titles were added to reflect current needs. A 2024 Budget column was added with values updated (delete, as was, changes) to reflect the 2024 priorities at UBC. The 2024 Oversight column was updated to assign every budget account an overseer(s). In the 2024 Notes column are a few explanatory notes to help the reader identify the nature of expenses for that account.

Here is a quick top-level overview (numbers rounded) of the proposed budget:

\$1,200,000	Compensation for 10 full-time and 8 part-time employees
94,500	Other employer personnel expenses (taxes, temps, team building, etc.)
545,824	Ministry and operations (training, facilities, support)
277,366	Missions, mercy, and deacon member care
546,000	Mortgage (principal, interest, additional principal)
58,310	Contingency (management, reserves)
\$2,700,000	2024 Budget Total

Additional Details. The Finance Committee discussed and decided to return to our traditional budget format and execution. This will allow the church leadership to also transition to a new focus and branding for 2024. Make no mistake, there is significant growth in the 2024 budget over 2023, acknowledging that we have an approximately \$4.1M mortgage to pay off and a maturing vision of the Lord leading us to focus on a campus, plant, or campus-to-plant model.

Each account has a designated account overseer (person or committee), whose responsibility it is to approve expenses and remain within the approved account budget allocation. The notes in the table are illustrative of the potential activities and things for which the budget account might use the funds.

#### Motion 2311.13. 2023 Staff Bonuses.

The lead pastor and the Personnel Committee moved that the church authorize a bonus to each UBC staff employee as follows: \$1,000 for full-time employees and \$500 for part-time employees. This has been a very busy year with much growth. The staff has done a great job working together as a team, and we'd like them to be blessed with this gift. By doing this now, the staff members will have the funds for their use during the holidays ahead. This is a tangible way of expressing thanks for their dedicated effort in 2023. The funds will come from the Staff Bonuses escrow account and not a budget account. Motion passed.
